**Introdiksyon bann mezir eksepsyonel pou bann PME ek bann travayer indepanndan**

Pou donn enn soutien siplemanter a bann *Petites et Moyennes Entreprises (PME)* ek osi bann travayer indepanndan (***self-employed***), *Ministere des Finances, de la Planification Economique et du Développement* pe anons miz an plas 5 mezir eksepsyonel :

**Travayer indepanndan/Self-Employed**

Enn sibvansyon pou enn sel fwa (***Self-Employed One-Off Grant Scheme***) pou enn montan Rs.10,000 pou verse a sak travayer indepanndan ;

**PME**

- (a) Enn *loan* san lintere (***SME Interest-Free Loan Scheme***) pou enn montan Rs.100,000, avek enn moratwar 5-an ;
- (b) Enn soutien pou bann PME pou enn *loan* san garanti avek enn to lintere 0.5% ek enn moratwar 1-an atraver ***Rs.1 Million SME Covid-19 Special Support Scheme***;
- (c) Extension pou TVA ki bizin paye le 31 Mars 2021 pou kapav paye ziska 15 Ziye 2021; ek
- (d) Enn *scheme* ki apel ***DBM One-Year Moratorium Scheme*** pou tou bann *loan* kinn fini pran.

***Self-Employed One-Off Grant Scheme*** pou enn sibvansyon eksepsyonel Rs.10,000 ki pou verse tou bann travayer indepanndan. Sa sibvansyon-la pou ed inpe plis ki 200,000 profesyonel.

***SME Interest Free Loan Scheme*** pou permet bann PMEs gagn enn *loan* san lintere avek enn moratwar 5-an, avek *Development Bank of Mauritius (DBM)*.

***Rs.1 Million SME COVID19 Special Support Scheme*** pou permet bann PMEs gagn enn *loan* san garanti avek DBM pou enn montan maximum de Rs.1 million avek enn to lintere 0.5% par an ek enn moratwar 1-an lor *repaïement* kapital ek lintere.

**Paiement TVA** pou bann PMEs ki ti bizin paye le 31 Mars 2021 pou kapav paye ziska 15 ziye 2021.

***DBM One-Year Moratorium Scheme*** se enn moratwar 1-an lor paiement kapital ek lintere pou tou bann *loan* ki existe ek kinn pran avek DBM.
